ASG/ BVCSA joint meeting planning – to develop a more effective working practice between the 2 organisations – this meeting was on 24<sup>th</sup> Sept when there was open and honest discussion about how to support the sector and sector leadership. Agreed a subsequent meeting to finalise who the ASG/ BVCSA work effectively together.

Revisited the concerns re the need for IG – BVCSA and CAB&D continue to work with the CCG to find a route through this so that it aligns with the type and use of data within the VCS

Progress report BVCSA – presentation at H&W Hub will provide same information Review of the diabetes commissioning and lessons learnt by BVCSA – report has been completed – key learning points will be shared by BVCSA
